According to a recent definition by Den Dekker, the concept can be broadly described as 'unilateral measures, bilateral and multilateral agreements as well as informal regimes ('politically binding' documents, 'soft' law) between States to limit or reduce certain categories of weapons or military operations in order to achieve stable military balances and thus diminish tensions and the possibility of large-scale armed conflict'.

Arms control and disarmament. The UN's founders hoped that the maintenance of international peace and security would lead to the control and eventual reduction of weapons. Therefore the Charter empowers the General Assembly to consider principles for arms control and disarmament and to make recommendations to member states and the Security Council. The Charter also gives the Security Council the responsibility to formulate plans for arms control and disarmament.

The history of arms control law indicates that the goals of arms control instruments traditionally relate to minimizing human suffering in conflicts and enhancing peace and security.²⁵⁰ In the words of the US Arms Control and Disarmament Agency, it is an effort "to reduce the likelihood of war and to limit the effects if it occurs".²⁶ The preamble and Article 1 of the ATT confirm the presence of both a humanitarian and a security-related purpose of the treaty.
